Comments: Under the supervision of a Hatchery Manager I, the incumbent will assist in the production and release of Central Valley fall-run Chinook salmon and American River steelhead to fulfill mitigation requirements of the United States Bureau of Reclamation for habitat lost due to the construction of Nimbus Dam. Incumbent will also be required to perform maintenance on grounds, equipment, and buildings at the Nimbus Hatchery. The Nimbus Fish Hatchery is located on the beautiful American River. The Hatchery is a key production facility supporting populations of Central Valley fall-run Chinook Salmon and American River steelhead trout and major contributor to California's commercial and recreational fisheries. This position consists of a wide variety of duties, many of which are labor intensive and tedious. Fish and Wildlife Technicians at the Nimbus Fish Hatchery may be spawning 40-pound adult Chinook salmon one day and inventorying millions of eggs or performing facility and equipment maintenance the next. Spawning of broodstock, diploid and triploid egg take, this will include egg counts, egg inventory, egg picking, egg packing, and egg shipping. Work with hatchery and scientific personnel on Red Band Trout fish culture, spawning and genetics management. Care of eggs, also including cleaning of incubation equipment. Cross-functional training while assisting at other hatcheries or wildlife areas occasionally. Incumbents will assist with maintenance of facilities and infrastructure; assist with fish stocking by air, horse, and truck; maintain and operate vehicles and various equipment. Comments: Do you want to support California's natural resources in the work you perform every day? You can have an impact by working collaboratively to help fulfill the Department of Fish and Wildlife's mission. The Department of Fish and Wildlife's Northern Region is seeking a motivated individual to work as a Fish and Wildlife Technician at our Trinity River Hatchery. As a Fish and Wildlife Technician you will be caring for hatchery fish, which includes feeding, treating, grading and inventorying production fish; trapping, sorting, spawning of anadromous fish; cleaning fish rearing raceway ponds and hatchery troughs, cleaning fish separation screens, collection and recording of fish loss. Care of eggs includes cleaning of incubation equipment: removing dead eggs; treating of eggs received before placing in incubation vessels; grading, weight counts and transfers to outside rearing ponds. Monitoring/Sampling water quality as required by the Regional Water Quality Control Board. Water monitoring also includes sampling for Aquatic Invasive Species (AIS). Work closely with hatchery employees, hatchery partner's, agencies, and researchers on all aspects of trapping, spawning and fish culture maintenance. Assist with drought related rescue of fish of special concern or threatened and endangered species; assist habitat restoration crews to implement and install habitat improvement projects. Occasionally assisting other hatcheries in cross-functional training. The incumbent will be required to provide maintenance, repairs and assist with installation of new equipment, this includes fish and water pumps, crowders, small engines, and nets/seines. In addition, you will need to assist with maintenance of vehicles, buildings, and grounds. Grounds maintenance includes mowing lawns, cutting weeds and minor tree trimming. Additional facility maintenance will include cleaning the office/break room, restrooms, shop, vehicle garages, meat/ice room and hatchery building. This position will be asked to operate fish transport trucks (which require possession of a valid Driver's License), fish/pond crowders, fish pumps, forklift (Required certification provided), tractors, lawn mowers, and various equipment. As a technician you will act as a lead person to Seasonal Staff in hatchery operations, oversee and train Seasonal Staff in hatchery assignment's, ground maintenance and construction projects. The incumbent will also assist in the training of new employees, and partners of the hatcheries. You will be required to take records of fish and egg inventories/losses/and size counts; chemical treatments, monthly water quality samples and reports; vehicle and equipment service records and use logs; driver's logbooks; hatchery supply inventories; attendance reporting, and other reports required.

Comments: Under the supervision of a Senior Environmental Scientist (Supervisory) and the lead of an Environmental Scientist, the incumbent will provide technical and office support for the Central Valley Angler Survey in the upper Sacramento River system. The incumbent will equip, maintain, operate, repair, and assign project sport-utility vehicles, trucks, and vessels, including jet boats, drift boats, and kayaks, for angler survey work and other biological research activities in the Sacramento River system. Recommend project gear and equipment purchases, compile bids, and work with the Environmental Scientist, Senior Environmental Scientist (Supervisory), and Fisheries Branch administrative staff to complete purchases. Maintain all project vehicle and skiff logs. Perform semi-skilled tasks relating to the design, fabrication, operation, and maintenance of angler survey and other fisheries research sampling gear using common shop power tools such as saws and drills. The incumbent will also assist the Environmental Scientist by training, directing, and mentoring seasonal staff in the safe use and maintenance of small boats used for collection of biological data in the Sacramento River anadromous and resident sport fisheries. In addition, the incumbent will assist with QA/QC of incoming field data and associated biological samples and enter data into an established relational database and with field work relating to the collection of data from Sacramento River sport anglers.
