# **Background**

WRC works under Commission direction to set and accomplish its work plan.

#### Committee Work Plan

Topics that have been referred by the Commission to WRC are displayed within a work plan for scheduling and tracking. The updated work plan is provided as Exhibit 1 and includes several proposed changes.

## Completed Topics

There are three work plan topics that WRC completed by providing a final recommendation to the Commission and that staff requests to remove from the work plan:

- Wildlife areas/public lands regulations
- Wild pig validations regulations
- White sturgeon (2023 and 2024) emergency regulations

#### Updated Topics

The periodic and annual regulations topics — other than inland sport fishing — are proposed to reflect discussion during the May 2024 WRC meeting. In addition, the three discussions and updates topics are expected to carry over to the May 2024 meeting.

#### New Topics

Commission staff has no recommendations for new topics for Commission referral to WRC.

#### **Next Committee Meeting**

The next committee meeting is scheduled for January 18, 2024 in Ontario, with webinar and phone options. In addition to standing agenda items (Department updates and future agenda items), four topics are proposed for the next WRC meeting:

- term regulation for white sturgeon fishing, all of which were vetted at previous WRC meetings.
- 2. Take of Nongame Mammals: Discuss concerns regarding indiscriminate take of nongame mammals.
- 3. Shotgun Wads: Initial discussion of plastic pollution caused by shotgun debris from waterfowl hunting.
- 4. Waterfowl Hunting in Southampton Bay: Initial discussion to explore potential regulation changes to address waterfowl hunting noise concerns specific to Southampton Bay, consistent with Commission direction at its October 2023 meeting.
